Who Do We Serve

The Children's Fund serves foster and lowincome children, newborn to age 18, in

San Mateo County. The children we serve must be referred by their San Mateo County case manager. This year, we expect to serve more than 2,500 children and teens.

### Who is Eligible for Our Services?

Our eligibility requirements for all our programs are the same:

- Must reside in San Mateo County
- Must be low income or in foster care
- Must be referred by a San Mateo County social worker, case worker, public health nurse, probation officer, or other San Mateo County Department staff.
- Must be an infant, child, teen ages newborn to 18 years old, or AB12 client
