# INTRODUCTION SUMMARY

Gross earnings for the month ending September 30, 2022 were 1.437%. Gross earnings for the quarter ending September 2022 was 1.374%. Current average maturity of the portfolio 1.39 years with an average duration of 1.32 years. The current Par Value of the pool is \$6.614 Billion. The largest non-government aggregate position is currently Barclay's 1.36%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2022-23 is 1.1625%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

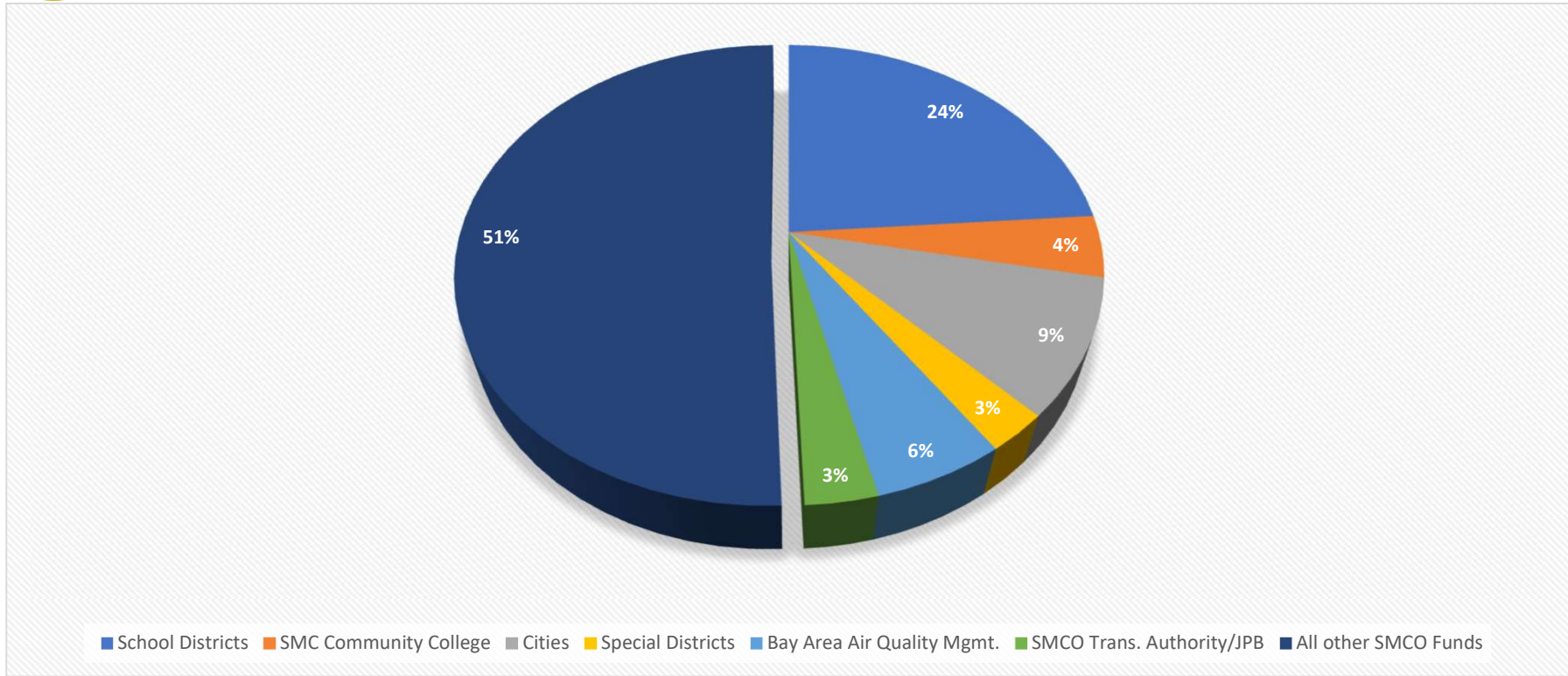
