MATERIALS PRESENTED FOR THE HEARING:

Applicants and members of the public are encouraged to submit materials to staff in advance of a hearing. All materials (including but not limited to models, pictures, videos, etc.) presented by any person speaking on any item on the agenda are considered part of the administrative record for that item, and must be retained by the Design Review Officer until such time as all administrative appeals are exhausted and the time for legal challenge to a decision on the item has passed. If you wish to retain the original of an item, a legible copy must be left with the Design Review Officer. The original or a computer-generated copy of a photograph must be submitted. Five (5) copies of written material should be provided for the Design Review Committee, staff and interested parties.

DECISIONS AND APPEALS PROCESS:

The Bayside Design Review Committee will make a decision when design review is the only application being considered, or make a recommendation to a different decision maker when additional planning applications are associated with the project (e.g., use permit, grading permit, etc.). Decision rulings for a project are appealable to the Planning Commission. Appeals must be filed no later than ten (10) business days following the decision at the San Mateo County Planning Counter (address listed above). Appeal application forms are available online and at the Planning Counter. The appeal fee is \$639.83 which covers additional public noticing.

Consideration of a major amendment to an approved Design Review Permit to construct a new 6,072 sq. ft. single-family residence (5,353 sq. ft. with a 709 sq. ft. attached garage) on a 20,074 sq. ft. legal parcel. The original project was approved by the Bayside Design Review Committee on July 3, 2013.

Consideration of a design review recommendation to allow replacement of existing two-story, rear decks totaling 518 sq. ft. with decks totaling 1,127 sq. ft. of a 3,235 sq. ft. single-family residence (2,660 sq. ft. with an attached 575 sq. ft. garage) on a legal 7,300 sq. ft. parcel. No significant trees are proposed to be removed. The project also requires a Home Improvement Exception (HIE) to allow a total of 187 sq. ft. of each new deck to protrude into the rear setback, having a 10-foot rear setback where a minimum of 20 feet is required, and for the upper deck and a portion of the lower deck to protrude into the daylight plane. A decision on the HIE will occur after April 5, 2016.
